RULES AND PRIVACY POLICY FOR THE USE OF THE CHARGING SYSTEM

- 1. The charging system is provided through a pole with 1 connector CCS2 with cable, 1 connector CHAdeMO with cable and 1 connector Type2-AC without cable
- 2. The access to the service area is allowed only to those who need to charge their vehicle and only for the time necessary for the charging operations.
- 3. It is mandatory for the user of the charging service to keep a correct and appropriate behavior. It is mandatory to respect the plants, the equipment, the charging station and the vehicles of the other users.

Whoever will cause damage, of whichever nature and intensity, will be obliged to refund it.

- 4. The use of the service is allowed only to those who are authorized to drive the vehicle to recharge.
- 5. The payment of the charging service takes place through an electronic system such as RFID card and/or smartphone app. It is not possible in any case to use cash money.
- 6. LaREU declines any responsibility linked to the use of the charging service.
 - The charging service takes place under the personal and exclusive responsibility of the user. The users of the service are aware to completely exempt La Ricarica Elettrica Udine (LaREU) from any responsibility, both regarding personal injuries and damages provoked to people and/or things. Please be aware that any insurance coverage is exclusively at the expenses of the user.
- 7. The charging service is open to the public H 24/7, with the exceptions of interruptions that might be necessary for maintenance and/or technical interventions of any type and duration.
 - LaREU declines any responsibility regarding the impossibility to fully or partially utilize the recharge service for the short, medium and long period, whatever the reason may be.
- 8. It is forbidden to stay in the dedicated area more than the necessary time to complete the charging service and it is forbidden to leave the vehicle unattended during the charging service.
- 9. Inside the area there are trees that are important for the landscape and under environmental protection. Do not walk near roots sticking out from the ground, do not eat any fruit that might be present, do not climb on trees and do not hang from the branches.

LaREU declines any responsibility linked to the previous actions.

- 10. LaREU declines any responsibility for damages to the vehicles and any other good brought inside the service area. For example, damages caused by: robbery, vandalism, weather events, lightning, electrical phenomena, over-voltage, overload, social or political events, flooding, riot, explosions, fire, arson, etc.
- 11. The charging service is under video surveillance for security reasons.

Inside the charging service are there is a security cameras system that allows the recording of images necessary to guarantee the safety of the users, protect the goods and organize and manage correctly the service. The information is recorded with secured cameras and the images will not be forwarder to third parties, except cases provided or requested by Law. The images are kept for 10 days and then automatically eliminated.

- 12. As stated by the article 13 of D.lgs. 196/03 "Codice in materia di protezione dei dati personali" and by the article 13 GDPR 679/16 "Regolamento europeo sulla protezione dei dati personali" every data and information provided or got by LaREU, will be archived for a period of 10 days and will be stored with electronic device for the sole purpose to guarantee the safety of the users, protect the goods and organize and manage correctly the service.
- 13. The data protection officer is LaREU Via Baldasseria Bassa n.340 Udine (UD), it is possible to contact it through Certified Email (PEC) to the email address dpo@laricaricaelettricaudine.it to exercise the rights by the article 7 of D.lgs 196/03 "Codice in materia di protezione dei dati personali" and article 13 GDPR 679/16 "Regolamento europeo sulla protezione dei dati personali".
- 14. The access to the area implies the acknowledgement and the explicit acceptance, in every part, of the rules listed here, the policy and the prohibited acts and duties associated with them.

THE ACCES TO THE CHARGING AREA IS FORBIDDEN:

- to people without an electric vehicle to recharge
- to all people with an electric vehicle that does not need to be charged immediately and simultaneously to the access to the area
- when weather conditions create a risk situation (e.g. heavy storms, lightingin, etc.)
- to bicycles and all other means of transport not enabled for electric charge
- to all vehicles with combustion engine not enabled for electric charge
- to all animals and pets of whatever size, even if with leash and muzzle



INSIDE THE CHARGING AREA AND NEXT TO THE CANAL IT IS FORBIDDEN TO:

- smoke or consume alcoholic beverages
- abandon or throw lit or unlit cigarette butts inside the area and/or in the water canal
- bivouac, make loud noises or shout
- leave and abandon any type of garbage inside the area and/or in the water canal
- · use flames or start fires of any kind.
- camp and/or spend the night inside the area
- urinate and/or defecate
- climb the trees, pick up flowers or plants, break tree branches and leaves
- climb and/or trespass the fence and the gates
- climb and/or lean over the canal barrier. Dive and/or swim in the water canal.
- behave in any way that could cause damage to other people and to one's self
- carry firearms, blunt objects and/or any type of knife
- hunt
- damage or alterate the infrastructures present inside the area
